A RESOLUTION ALLOWING THE LOCAL CHIEF EXECUTIVE, HON. JOSE MARIA O. HIZON, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF INTERIOR & LOCAL GOVERNMENT (DILG) WITH RESPECT TO THE IMPLEMENTATION OF THE PROJECT ENTITLED "EXCAVATION OF CABETICAN-TINAJERO CREEK" IN THE AMOUNT OF ONE MILLION PESOS (P1,000,000.00) UNDER THE PERFORMANCE CHALLENGE FUND (PCF) OF THE DEPARTMENT

WHEREAS, the Municipal Government of Bacolor had programmed a project entitled "Excavation of Cabetican-Tinajero Creek" incorporated under the approved Annual Investment Plan (AIP) for CY 2014, funded under the 20% Development Fund with an appropriation of Two Hundred Fifty Thousand Pesos (P250,000.00);

WHEREAS, to facilitate the implementation of the entire project, the Performance Challenge Fund (PCF) which was received by the municipality for being an awardee of the "Seal of Good Housekeeping" Silver Category amounting to One Million Pesos (P1,000,000.00) will serve as an augmentation to the available resources of the municipality, having an initial project cost of One Million Two Hundred Fifty Thousand Pesos (P1,250,000.00);

WHEREAS, the proposed project is eligible for the PCF subsidy for it supports the national priorities of the present administration in achieving the Millennium Development Goals (MDG), preparedness to disasters and adaptation to climate change, sustainable environmental management and transparent & accountable local governance which are implementable within one (1) year from the date of receipt of the PCF Check;


NOW THEREFORE, the Sangguniang Bayan in session assembled upon motion of Hon. Voltaire J. San Pedro, unanimously seconded;
