Resolution No. 91, S-2014

A RESOLUTION ALLOWING THE ESTABLISHMENT AND OPERATION OF A PRIVATE SLAUGHTERHOUSE AT ZONE 2, CABALANTIAN, BACOLOR, PAMPANGA OWNED AND OPERATED BY PAMPANGA'S BEST INC.

WHEREAS, the Municipality of Bacolor has no slaughterhouse, whether public or private, operating within its territory;

WHEREAS, there is a need to regulate and control the slaughtering of pigs/hogs within the territorial jurisdiction of Bacolor;

WHEREAS, a slaughterhouse will be beneficial for the people of the Municipality of Bacolor as it will provide fresh meat and control the practice of unhygienic slaughtering of pigs for meat;

WHEREAS, a slaughterhouse will provide new job opportunities for the people of the Municipality of Bacolor;

WHEREAS, a slaughterhouse will also provide the people of the Municipality of Bacolor who intend to seek employment abroad in the related field the required experience and certifications;

WHEREAS, Pampanga's Best Inc. has signified its intent to establish and operate a private slaughterhouse which will be located at Zone 2, Cablantian, Bacolor, Pampanga;

WHEREAS, the Barangay Council of Cabalantian interposes no objection in the operation of the same, as embodied under Resolution No. 001, S-2012;

WHEREAS, the said slaughterhouse will generate income to the LGU of Bacolor, wherein twenty five centavos (P0.25) will be charged to every kilo/carcass of slaughtered animal, 75% of it will go to the LGU and 25% of it will go to National.

NOW THEREFORE, the Sangguniang Bayan in session assembled upon motion of Hon. Ariel C. Sta. Cruz, duly seconded by Hon. Efren S. Blanco;

BE IT RESOLVED, as it is hereby resolved to allow the establishment and operation of a private slaughterhouse at Zone 2, Cabalantian, Bacolor, Pampanga owned and operated by Pampanga's Best Inc.;


RESOLVED FINALLY, that a copy of this resolution be furnished to Pampanga's Best Inc. for their ready reference.
